## **Courses Taught:**

- Legal Practice I and II: The Legal Practice course is designed to teach students legal analysis, research, and writing (including the central art of persuasive writing); oral advocacy; and other selected aspects of the practice of law. In the Legal Practice course, students receive both group and individualized instruction. Legal Practice I and II are required first-year courses presented in a sequence (material taken from a course description provided by the University of Michigan Law School to current and prospective students).
- Senior Judge Seminar I and II: In the Senior Judge Seminar, students work closely with Legal Practice professors in connection with various aspects of the first-year Legal Practice course. Each Legal Practice professor interviews, chooses, and supervises the Senior Judge Seminar students for the Legal Practice section(s) taught by that professor (material taken from a course description provided by the University of Michigan Law School to current and prospective students). Senior judges serve as research and teaching assistants for the first-year Legal Practice course. Senior judges also get advanced legal writing training in the form of guided creation of complex research problems and advanced writing documents like judicial bench briefs.
- Legal Practice Skills: This class is required for students taking the Legal Practice I class. It focuses on some of the skills generally regarded as necessary for effective and responsible participation in the legal profession. The professional skills taught vary from year to year, but the covered skills include such subjects as advocacy, negotiation, alternative dispute resolution, and transactional drafting (material taken from a course description provided by the University of Michigan Law School to current and prospective students).
- Legal Persuasion: Techniques of Great American Lawyers and Activists: This course was a one-credit mini-seminar I designed and taught during the 2006-2007 school year. I introduced various persuasive tools and techniques, including (1) classical rhetorical devices and their relevance in modern legal argument; (2) the use of publicity as a persuasive tool (reading relevant ethical rules as well as the published trial transcripts of the trial of Susan B. Anthony for illegal voting); (3) persuasion in the political arena (studying Abraham Lincoln's speech at Cooper Union as

well as portions of the Lincoln-Douglas Debates); persuasion in judicial dissents (reading and discussing the writing of Oliver Wendell Holmes, Jr.); and the use of social science data as persuasive evidence (studying the Brandeis Brief as well as the oral arguments in Brown v. Board of Education).

- Defending Evil: In this seminar, students explored what it means to defend an "evil" client (and whether the term "evil" is even an appropriate term to use). The discussion necessarily required students to come up with some sort of working definition of "evil," a definition that evolved as the seminar progressed. We then spent much of the semester examining and critiquing the defense tactics used by lawyers for some of the most uniformly despised criminals in history. We did so by viewing documentaries and reading original court documents. Specifically, students addressed the persuasive techniques used by the lawyers (from classical rhetorical techniques to the use of media to persuade). Students also engaged in a discussion of (1) what made the lawyers effective (or not) and ethical (or not); and (2) how we balance the human reaction to the idea of defending someone like a serial killer with our fundamental belief in the right to counsel. The seminar concluded with a discussion of the "problem" of innocence: how do our views of the defense of evil change when it turns out we get it very wrong sometimes?
- Advanced Legal Writing: Business Drafting: The course introduces students to the key skills necessary to represent both individual and corporate clients in business transactions. Students learn how lawyers approach business transactions from a problem solving (and problem avoiding) perspective. The course engages students in simulations at each stage of the deal timeline, from initial client contact to the drafting, negotiation, and signing of closing documents. Through in-class simulations and exercises, students learn how to translate a client's business objectives into clear, precise, and concise agreements that stand up to legal challenge. Heavy emphasis is placed preventative lawyering (anticipating problems and drafting to protect the client from unnecessary risk).
- Lawyering Skills I & II: Course focuses on skills that all lawyers use, including fact investigation, interviewing, legal writing and analysis, legal research, negotiation, and oral advocacy.
