George A. Hopper Memorial Luncheon Scholarship

The Hopper Luncheon is the premier Fresno County Bar event at which law students, young lawyers, experienced attorneys, and members of the judiciary gather to recognize the spirit and legacy of Justice Hopper. Justice Hopper served on the Fifth District Court of Appeal where he made considerable efforts to mentor and educate young trial attorneys. His spirit and legacy continue through this annual event to recognize young attorney mentorship.

The Fresno County Young Lawyers Association ("FCYLA") is now accepting applications for the George A. Hopper Memorial Scholarship. The amount of the scholarship is \$1,000.00. A completed application form and all documentation should be emailed to Georgehopperscholarship@gmail.com on or before September 30, 2024.

Interested applicants must meet the following criteria:

- 1. Be currently enrolled as a second, third, or fourth year law student in good standing;
- 2. Have a demonstrated connection to the San Joaquin Valley, as well as a desire to practice law in Fresno, Madera, Merced, Kings, or Tulare County; and
- 3. Be able to attend the annual Fresno County Young Lawyer Hopper Luncheon on October 10, 2024, in Fresno, California.

Scholarship funds shall be used solely for educational purposes such as the costs of studying for or taking the Bar Examination, or in another manner appropriately related to the recipient's preparation for the practice of law. Scholarship funds will be awarded in person at the annual Fresno County Young Lawyer Hopper Luncheon on October 10, 2024.
