In addition to teaching at California Western, I am also an adjunct professor at Loyola Law School, teaching one section of Ethical Lawyering, a course of 30 students, covering rules of professional responsibility and interviewing and counseling skills. Loyola's Ethical Lawyering course includes simulated counseling exercises, requiring me to prepare several hypothetical client files, coordinate with the actors and meet with students to strategize regarding exercises.

As an associate clinical professor, I taught two first-year Legal Writing sections of approximately 20 students per section. In Legal Writing, students compose two legal memoranda and one Memorandum of Points and Authorities during the year-long course. I met regularly with Legal Writing students in office hours and individual meetings to evaluate their papers and provide detailed feedback. I also taught one section of Ethical Lawyering, as described above.

During the Fall 2022 semester, I also served as the director of Loyola's Academic Success Program (ASP). I advised ASP students and taught workshops about law school studying skills.

As an adjunct professor, I have also taught Legal Drafting, which included teaching legal reasoning and objective and persuasive legal writing to approximately 8 to 15 students per semester. Students completed between two and four written assignments per semester, including a client letter, a litigation strategy memorandum (14 pages), a complaint and a settlement agreement. During the semester I met with each student individually and provided written comments on one or more ungraded drafts.

As an adjunct clinical professor, I taught Basic Bar Studies, a course focused on Bar Exam Essays. I met with students individually and provided written comments on multiple essays over the course of the semester.
